Protect Yourself from Impersonation Scams

Impersonation scams have dominated the list of reported scams in both 2021 and 2022, with the Federal Trade Commission disclosing a staggering \$660 million in losses attributed to various impersonation scams.¹ These fraudulent activities typically commence with unsolicited phone calls, text messages, or emails that appear to originate from reputable businesses. In these deceptive schemes, criminals pose as employees of legitimate organizations, aiming to phish for valuable personal information. The primary objective of these scams is to deceive and manipulate victims into divulging their personal identifiable information.

How to Avoid Falling Victim

Don't Trust Caller ID: Fraudsters can manipulate caller ID information to appear legitimate, so always exercise caution when receiving calls from unfamiliar numbers.

Don't Be Pressured to Act Quickly: Scammers often use urgency to pressure their victims into making hasty decisions. Take your time to verify the authenticity of any requests.

Don't Click Links or Attachments Unexpectedly: Avoid clicking on links or opening attachments in messages from unknown sources. Verify the sender's identity before taking any action.

Don't Share Personal or Financial Information: Never disclose sensitive information like Social Security numbers, debit card details, PINs, multifactor authentication codes, or online banking credentials to unsolicited callers or via email/text.

Protecting Your Membership with TFCU

At TFCU, we do make outbound service calls to our members. However, it's important to note that legitimate attempts to verify debit card activity only require simple responses (YES or NO). Please be aware that when TFCU contacts you, our representatives will **NEVER** request the following information:

- •Full Social Security Number
- •Debit card number and/or PIN
- •Multifactor Authentication Codes (verification codes sent via email or text)
- •Online banking usernames and passwords

If you receive a call, text, or email from TFCU and are uncertain about its authenticity, **do not proceed** and contact TFCU directly. The **only valid phone number** to reach TFCU is **(508) 824-6466**.

Monitoring Your Credit Report

The three major nationwide credit bureaus (Equifax, Experian, and TransUnion) offer a centralized service that allows anyone to request free annual credit reports through the **Annual Credit Report Request Service**. You can obtain your free annual credit reports in the following ways:

Beware of advertisements offering free credit reports from sources other than the **official Annual Credit Report Request Service**. There is only one authorized service for obtaining your credit report for free.
