	Taunton Federal Credit Union does not share with nonaffiliates so they can market to You.
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to You.
	Our joint marketing partners include insurance companies, credit card companies, and other financial service companies.
