A Second Chance Checking can be opened only if the member currently owes less than \$600 to other financial institutions. Second Chance Checking is subject to TFCU's standard deposit policies and fees. The account may be closed at anytime for any reason, including but not limited to overdrafts or fraud. ²See Community Development Loan program for details. Maximum loan amount of \$600. ³Qualifying Direct Deposit is a credit of your salary, pension, social security or other regular monthly income. Transfers from one account to another or deposits made through ACH do not qualify as direct deposit. ⁴TFCU's Mobile Banking is offered free, however data usage fees may be incurred from your carrier. ⁵Bill Pay is offered at no charge provided at least one transaction is processed per month, otherwise a \$4.95 fee will be imposed. ⁶TFCU will not charge fees for utilizing foreign ATMs, however, you may still incur a fee from the ATM owner.
